Industry in three important ways. First, the reduction in the Dividend Tax renders dividend payments by the industry more viable thereby attracting traditional investors to technology equities. Second, the reduction in personal tax rates by 2% or more across the board provides greater incentives for work and savings. Third, the increase in small business capital expenditures deduction from \$25,000 to \$100,000 will substantially boost technology purchasing by small business.

The impact of the Plan on Government receipts is unknown. Republicans believe economic benefits of the Plan will offset the projected \$350 billion loss in tax receipts. Democrats argue that the Plan will cost more than \$350 billion and ignore the dynamic reaction of tax-payers.

Impact on Government should not be the issue. The more appropriate inquiry focuses on the benefits to con-

sumers and business. From that vantage point, the Plan is a definite "Go".

### HILLARY ROSEN: HERO OR VILLAIN?

he announcement of Hillary Rosen's retirement marks a turn of events for the music industry. Rosen has enjoyed some success in using copyright law to raise the issue of Internet piracy. But this success has not restored the financial health of an ailing industry being disrupted by increasingly sophisticated technologies in the hands of avid music fans that are hard pressed to pay \$20 for the average music CD.

Ms. Rosen's success in raising the issue gave the industry a false sense of optimism in its current business model. To the extent Ms. Rosen was able to focus attention on copyright piracy she precluded the urgency of changing the model to meet the demands of the fans. Hence, her heroism had a long-term villainous effect on an industry facing collapse because it can no longer control distribution of its products.

The true hero of the music industry is Steve Jobs, the Apple executive who was able to orchestrate a new vision. The Apple iTunes business model meets the demands of fans and artists by leveraging new technologies in their favor.



#### **FCC Media Rule Changes**

ecent FCC Media Changes allowing consolidation of media outlets under single ownership favors Internet vendors. These rule changes raise the 35% national audience cap to 45%, allow big newspapers to own top-rated TV or radio stations in the same market and allow networks to own more of their affiliates.

Critics of the Rule changes argue that allowing ownership of media outlets to consolidate further in the hands of a few owners will lock-out the news entrepreneur and minority voice from traditional media outlets. The complaint is that the same national stories will air over and over, with community news and minority views being ignored as too marginal for profit.

The critics are right about the quality of news reporting by the giant media owners under these Rule changes. However, they ignore the reaction of the consumer. If the traditional media outlets do not provide sufficient diversity, the American consumer will seek alternatives. This is good news for Internet, cable and XM Radio vendors who are not governed by these rules.

### E-BAY THIEVES THWARTED BY TECHNOLOGY

onvicted E-Bay technology thieves Michael Paul Jackson and Russell Dana Smith illustrate the importance of using a secure payment escrow service for online purchasing. Jackson stole more than \$120,000 from more than 100 e-bay users who purchased laptops, digital cameras and computers that were never delivered from Jackson. Smith raked in more than \$1,000,000 from 1000 victims in just a few weeks using the same scam.

E-Bay buyers and others purchasing web products can avoid this fate using an escrow service. The escrow agent receives and holds funds while you await product delivery. Upon confirmation, the funds are released to Seller. The leading escrow payment service for on-line transactions is Escrow.com .

- Interaction: Does the user know what they can do at the Website?
- Speed: How long does it take the user to perform functions for which the visit was initiated?

#### THE TECHNOLOGY JESTER

Vest Virginia has abandoned its alliance with Massachusetts in challenging the Microsoft Antitrust Settlement. The West Virginia settlement with Microsoft leaves only Massachusetts to continue the battle.

The latest settlement involved a Microsoft payment of \$300,000 in legal fees to the West Virginia Attorney General's office and providing approximately \$20 million in vouchers for computer hardware and software for the people of West Virginia. The vouchers include products from Microsoft rivals.

The Justice Department AntiTrust Settlement emphasizes competition through innovation, rather than government regulation. The position of the Massachusetts Attorney General appears out of step with the spirit of the law as well as the sentiments of 16 other Attorneys General around the Nation that have endorsed the settlement.

### E-GOVERNMENT YOU CAN ACTUALLY USE

ederal, state and local governments have been very active in implementing cyberspace models to increase efficiency and improve the delivery of services to citizens. Three recent initiatives by the federal government illustrate the advantages of E-Government:

**NASA**: NASA officials were very successful in soliciting information from citizens on the Space Shuttle Columbia disaster at www.nasa.gov.

**White House:** A new on-line chat facility at the White House allows U.S. Citizens to ask questions by e-mail of high-level federal government officials at www.whitehouse.gov.

**Terrorism:** The Department of Homeland Security posts guidelines for disaster recovery and terrorist attack at www.readv.gov.

**Benefits:** Seniors can checkout eligibility for Government Programs providing medical benefits at www.benefitscheckup.org.

**Regulations:** You can comment on new regulations proposed by the federal government at www.regulations.gov.

These applications empower citizens rather than government and are good examples of how technology can be used by government to improve our daily lives.

### E-GOVERNMENT THAT BORDERS ON THE RIDICULOUS

hile some federal and state agencies receive accolades for leveraging high-tech to empower citizens, others are sad examples of overreaching.

**Wisconsin:** The State of Wisconsin recently passed a ban on violent video games. A similar statute in Indianapolis has been ruled as unconstitutional.

**California:** The State Legislature of California is attempting to tax all sellers conducting on-line transactions with California buyers, regardless of seller location.

**Alabama:** Senator Shelby (R-AL) introduced broad legislation attempting to outlaw Internet gambling by limiting the use of credit cards for payment processing of gambling debts.
